

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.1000 per \$100 valuation has been proposed by the governing body of Crane County Emergency Services District No. 1

PROPOSED TAX RATE	\$0.100000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.111740 per \$100
VOTER-APPROVAL TAX RATE	\$0.115677 per \$100

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for Crane County Emergency Services District No. 1 from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval tax rate is the highest tax rate that Crane County Emergency Services District No. 1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Crane County Emergency Services District No. 1 is not proposing to increase property taxes for the 2024 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 18, 2024 at 7:00 p.m. at 212 W. 6th Street, Crane, Texas 79731.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Crane County Emergency Services District No. 1 is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Commissioners of Crane County Emergency Services District No. 1 at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Crane County Emergency Services District No. 1 last year to the taxes proposed to be imposed on the average residence homestead by Crane County Emergency Services District No. 1 this year.
